EASTERN IDAHO PUBLIC HEALTH (EIPH) - (excerpt from their daily update on eiph.idaho.gov) Positive COVID-19 Test Results Case

#25: We are reporting a positive COVID-19 test result for a female in her 60s in Bonneville County. This individual was not hospitalized and is recovering at home. Community spread of COVID-19 is identified.

Case #26: We are reporting a positive COVID-19 test result for a male in his 40s in Madison County. This individual was not hospitalized and is recovering at home. This individual had contact with a confirmed case of COVID-19 while out of the State of Idaho.

Case #27: We are reporting a positive COVID-19 test result for a male in his 40s in Teton County. This individual was not hospitalized and is recovering at home. The individual had contact with a confirmed case of COVID-19 while out of the State of Idaho.

CONSTRUCTION POLICIES AND PLANS

County Commissioners approved the COVID-19 Building Department Policies today. The full document is available here. The City of Driggs will continue to monitor whether construction sites are compliant with the Governor's Order, the City's Declaration of Emergency, and the CDC recommendations, and will address any further concerns as they may arise. The City of Tetonia will be discussing construction restrictions at their next meeting on April 13, 2020 at 7:00 pm. It will be a virtual meeting and all meeting details will be posted on the City of Tetonia website by Friday April 10.

VISITATION AND LODGING RESTRICTIONS

Driggs emphasizes that, under the Governor's Order, no Hotels, or other temporary lodging facilities (VRBO's, or Airbnb's) may operate, except to house essential workers.

Teton County and the City of Victor are considering visitation and lodging restrictions. Information will be provided from both entities as soon as it is available.
